## ADVANCED EMERGENCY MEDICAL TECHNICIAN

Incumbents work under the general supervision of a designated supervisor representing the Fire District, and their work is reviewed for soundness of medical judgment and overall adequacy by the supervisor and the district's designated medical director for the EMS service. Does related work as required.

The title of Advanced Emergency Medical Technician is **competitive**, requiring applicants to meet minimum qualifications established for the position and successfully meet civil service examination requirements.
